

TERMS AND CONDITIONS APPLICABLE TO THE QATAR GOODWOOD FESTIVAL L'ORMARINS BEST DRESSED COMPETITION 2020

The terms and conditions set out in this section apply to all of the competitions operated by the Goodwood Group and L'Ormarins. Additional Terms and Conditions are included in Section 2.

1. WHO IS PROMOTING/SPONSORING THIS PRIZE DRAW?
