

TERMS AND CONDITIONS APPLICABLE TO THE GOODWOOD ROAD RACING COMPANY LIMITED GOODWOOD REVIVAL SETTRINGTON CUP RACE FLAG COMPETITION

The terms and conditions set out in this section apply to all of the competitions and draws operated by the Goodwood Group. Additional Terms and Conditions are included in Section 2.

1. WHO IS PROMOTING/SPONSORING THIS COMPETITION?

The promoter of this COMPETITION is the Goodwood Road Racing Company Limited ("**Goodwood**"), registered office: *Goodwood, Chichester, West Sussex PO18 0PX*. You can contact Goodwood at the above address.

2. CAN I ENTER?

You are eligible to enter this COMPETITION if you meet the following requirements:

- **You complete** and submit a Goodwood Revival Settrington Cup flag design; and
- **You are** aged between 4 and 11 years old; and
- **You are NOT** an employee or immediate family of an employee of any of the companies in the Goodwood Group; and
- **You are NOT** involved in any part of the administration and execution of this competition

3. RULES ABOUT ENTRY

Only one entry per person is allowed.

The winner, along with a parent or legal guardian **MUST** be available to attend the Settrington Cup Testing Day held on Sunday 24 July 2022 at the Goodwood Motor Circuit.

The winner, along with a parent or legal guardian **MUST** be available to attend the Goodwood Revival event on Saturday 17 September 2022 and Sunday 18 September 2022.

4. HOW ARE WINNERS SELECTED AND NOTIFIED?

We, or a company acting under our authorisation, in the presence of an independent adjudicator, will select one flag design winner from all eligible entries received from entrants whose place of residence is within the UK

If you are a potential winner, we will notify you by sending a message to the email address, used at time of entry. If our notification is returned as undeliverable, or we are unable to reach you for any reason, we may randomly select an alternate winner.

If there is a dispute as to who is the potential winner, we will consider the potential winner to be the authorised account holder (parent or legal guardian) of the email address used to register.

If you are a potential winner, we may require you to sign a declaration of eligibility and liability/publicity release before the prize can be fulfilled. Those under the age of 18 may require their parent / legal guardian to sign a declaration of eligibility and liability / publicity release.
