

**TERMS AND CONDITIONS APPLICABLE TO
GOODWOOD RACECOURSE – AUGUST BANK HOLIDAY PRIZE DRAW**

The terms and conditions set out in this section apply to all of the competitions and draws operated by the Goodwood Group. Additional Terms and Conditions are included in Section 2.

1. WHO IS PROMOTING/SPONSORING THIS COMPETITION?

The promoter of this PRIZE DRAW is GOODWOOD RACECOURSE (“Goodwood”), registered office: Goodwood Racecourse, Chichester, West Sussex, PO18 0PS. You can contact Goodwood at the above address.

2. CAN I ENTER?

You are eligible to enter this COMPETITION if you meet the following requirements:

- You have bought tickets to Goodwood’s August Bank Holiday racing fixture (23 – 25 August 2024);
- You are over the age of 18 years old; and
- You are NOT an employee or immediate family of an employee of any of the companies in the Goodwood Group; and
- You are NOT involved in any part of the administration and execution of this competition

3. RULES ABOUT ENTRY

Only one entry per person is allowed.

4. HOW ARE WINNERS SELECTED AND NOTIFIED?

We, or a company acting under our authorisation, in the presence of an independent adjudicator, will conduct one or more random drawings (depending on the terms of the particular draw) from all eligible entries received from entrants whose place of residence is within the UK.

If you are a potential winner, we will notify you 48 hours before the event by sending a message to the e-mail address, or by phone using the provided contacted number, used at time of entry. If our notification is returned as undeliverable, or we are unable to reach you for any reason, we may randomly select an alternate winner. If there is a dispute as to who is the potential winner, we will consider the potential winner to be the authorised account holder of the e-mail address used to register.

If you are a potential winner, we may require you to sign a declaration of eligibility and liability/publicity release before the prize can be fulfilled. If you are a potential winner and you are under the age of 18, we may require that your parent / legal guardian sign a declaration of eligibility and liability/publicity release. Section Two

TERMS AND CONDITIONS APPLICABLE TO THE GOODWOOD RACECOURSE AUGUST BANK HOLIDAY PRIZE DRAW ("Rules")

The terms and conditions set out in this section apply to the GOODWOOD RACECOURSE AUGUST BANK HOLIDAY PRIZE DRAW. Additional Terms and Conditions applicable to all draws are included in Section 1.

This promotion will be simply referred to as the "Event" throughout the rest of these Rules. In these rules, "we," "our," and "us" refer to Goodwood Racecourse, the sponsor of the draw. "You," "yourself" refers to an eligible draw entrant.

1. WHAT ARE THE START AND END DATES?

This starts at 09:00 hrs Greenwich Mean Time (GMT) on 20 August 2024 and closes 48 hours before gates open on each of the three racedays (23, 24 and 25 August 2024). Those that purchased tickets before 09:00 on 20 August will automatically be entered into the draw.

2. HOW DO I ENTER?

By purchasing admission tickets to any day of our August Bank Holiday racing fixture (23 – 25 August 2024).
