

## Terms and Conditions applicable to Goodwood Motor Circuit, Classic Driving Experiences Prize Draw

The terms and conditions set out in Section One apply to all of the competitions and prize draws operated by the Goodwood Road Racing Company Limited (“Goodwood”), whose registered office is at Goodwood, Chichester, West Sussex PO18 0PX, company number 466176. Additional Terms and Conditions for each individual competition and prize draw are included in Section Two. The terms and conditions set out in Section One and Section Two are referred to as the “Rules”. In these rules, "we," "our," and "us" refer to Goodwood and "you" and "yourself" refers to an eligible competition or prize draw entrant.

### Section One

#### 1. Who is promoting this prize draw?

The promoter of this prize draw is Goodwood Road Racing Company Limited (“**Goodwood**”), registered office: Goodwood, Chichester, West Sussex PO18 0PX. You can contact Goodwood at this address.

#### 2. Can I enter?

You are eligible to enter this prize draw if you meet the following requirements:

- **You are** 18 years or older at the time of entry.
- **You** answer the competition question and fill in the prize draw form on a tablet at Goodwood Motor Circuit.

**You will need a full clean UK driving licence in order to fulfill the prizes.**

Within two weeks of the Closing Date specified in Section Two we, or a company acting under our authorization, in the presence of an independent adjudicator, will conduct one or more random drawings (depending on the terms of the particular draw) from all eligible and correctly answered entries; The winners will be notified by email.

#### 5. Rules about prizes

There is no cash alternative. We reserve the right to substitute prizes of equal or greater value at any time. Prizes are awarded at our discretion.

#### 6. What other conditions am I agreeing to by entering this prize draw?

If cheating, a catastrophic event, or any other unforeseen or unexpected event that cannot be reasonably anticipated or controlled, (also referred to as force majeure) affects the fairness and /or integrity of this prize draw, we reserve the right to cancel, change or suspend this prize draw.
